- PHMA Election 2026-2028 Circular Ref.No.2026/PHMA/ELE-CIR-1/105 Dated: 15-07-2026.
- The Pakistan Hosiery Manufacturer & Exporter Association (PHMA) through its Central Executive Committee meeting held on 11th July 2026 had approved and announced election schedule as per rule 14 of Trade Organization Rule 2013 & also appointed Election Commission as per Rule 16 of Trade Organization Rules 2013 to function as per Rule 17 & to conduct Elections as per Rule 18 & 19 of Trade Organization.
- Membership of PHMA is granted/renewed as per Rule 11 of Trade Organization Rules & members are eligible to vote as per Rule 15 of Trade Organization Rules 2013.
- The tenure of elected Executive Committee members & Office Bearers shall be two years as per Rule 21 (15) of Trade Organization 2013.
- As per Rule 21(15) on completion of term, office Bearers & Members of Executive committee shall not be eligible to contest election in any representative capacity for the next two years.

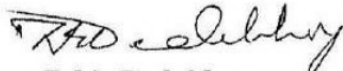
NOTE:
